2. **Limitations of this Agreement.** This Agreement is limited to the subject matter of covenants not to compete or solicit as described in this Agreement.
3. **Covenant Not to Compete.** Stowers Real Estate agrees to refer any property sale from the referred client back to the referring agent.
4. **Modifications.** This Agreement may be modified only in writing executed by both the Referring Agent/Brokerage and Stowers Real Estate.
5. **Prior Understandings.** This Agreement contains the entire agreement between the parties with respect to the subject matter of this Agreement. The Agreement supersedes all prior understanding, agreements, or representations.
6. **Waiver.** Any waiver of a default under this Agreement must be made in writing and shall not be a waiver of any other default concerning the same or any other provision of this Agreement. No delay or omission in the exercise of any right or remedy shall impair such right or remedy or be constructed as a waiver. A consent to or approval of any act shall not be deemed to waive or render unnecessary consent to or approval of any other or subsequent act.
7. **Jurisdiction and Venue.** This Agreement is to be construed pursuant to the laws of the State of California. You agree to submit to the jurisdiction and venue of any court of competent jurisdiction in Contra Costa County, Alameda County, Santa Clara County, San Joaquin County, San Francisco County and Orange County, California without regard to conflict of laws provisions, for any claim arising out of this Agreement.
